PROGRAMME AGREEMENT

for the financing of the Programme "Children and Youth at Risk" hereinafter referred to as the "Programme Agreement"

between

The Financial Mechanism Committee established by Iceland, Liechtenstein and Norway hereinafter referred to as the "FMC"

and

The Ministry of Finance,
hereinafter referred to as the "Focal Point",
representing Estonia,
hereinafter referred to as the "Beneficiary State"
together hereinafter referred to as the "Parties"

Article 1

1. In Annex 1 to the Programme Agreement, under the heading "3.5 Small Grant Scheme", in the third line "Grant Amount at Project Level" the values:

€5,000 – 30,000

Shall be replaced by the following values:

2. In Annex 1 to the Programme Agreement, under the heading "3.5 Small Grant Scheme", in the eighth line "Grant Amount at Project Level" the values:

€5,000 - 60,000

Shall be replaced by the following values:

€5,000 - 150,000

3. In Annex 2 to the Programme Agreement, under the heading "3.2 Open calls and availability of funds", in the fifth and sixth paragraphs, the text:

"Call for proposals under the output 6: Social inclusion of excluded young people and prevention of reoffending behaviour shall be launched no later than in the second quarter of 2013 and make available €340,000.

There shall be at least one call for proposals under each small grant scheme. The call for proposals under output 3: Community based crime prevention measures enforced in large number of municipalities shall be launched no later than first quarter of 2013 and make available €295,146. The call for proposals under output 7: Aftercare for incarcerated youth shall be launched no later than second quarter of 2013 and make available €474,650."

Shall be replaced by the following text:

"Call for proposals under the output 6: Social inclusion of excluded young people and prevention of reoffending behaviour shall be launched no later than in the first quarter of 2014 and make available €340,000.

There shall be at least one call for proposals under each small grant scheme. The call for proposals under output 3: Community-based crime prevention measures enforced in large number of municipalities shall be launched no later than first quarter of 2014 and make available

€295,146. The call for proposals under output 7: Aftercare for incarcerated youth shall be launched no later than fourth quarter of 2013 and make available €474,650."

4. In Annex 2 to the Programme Agreement, under the heading "5.4 Small Grant Schemes", the text:

"Not applicable."

Shall be replaced by the following text:

"Two small grant schemes will be organised. The small grant schemes operator is the Criminal Statistics and Analysis Division of the Ministry of Justice of the Republic of Estonia. The minimum amount of grant assistance applied for under the small grant scheme for community-based crime prevention measures enforced in large number of municipalities is €5000; the maximum amount is €60,000. The total amount is €295,146. The minimum amount of grant assistance applied for under the small grant scheme for aftercare for incarcerated youth is €5000; the maximum amount is €150,000. The total amount is €474,650."

5. The modification described in paragraphs 1, 2, 3 and 4 above take effect from 13 March 2013.

Article 2

This Addendum constitutes an integral part of the Programme Agreement. Except for the stated above (Article 1), the Programme Agreement remains unchanged.
